The meeting will be held at the Arizona Game and Fish Department, 5000 West Carefree Highway, Phoenix, Arizona 85086. The Board will discuss and may vote to take action on the following matters:

**1. Welcome and Introductions of the Arizona Game and Fish Commission Appointment Recommendation Board.**

**2. Review, Approval, and Signing of Minutes.**

The Recommendation Board will review, approve, and conduct the signing of the Boards meeting minutes from the November 12, 2010 and November 15, 2010 meetings.

**3. Discussion and Recommendations for the Arizona Game and Fish Commission Appointment Recommendation Board Operating Procedures.**

The Recommendation Board will be discussing their 2010 Operating Procedures and any recommendations for change. The Board may vote to take action on this item.

**4. Future Meeting Schedule and Locations.**

The Recommendation Board is not scheduled to reconvene until November 2011, when they will be reviewing applicants for the Governor's 2012 Appointment for the Arizona Game and Fish Commission.

Agenda items not noticed for a specific time may be taken out of order. The Board may go into Executive Session for the purpose of obtaining legal advice from the Attorney General's Office on any of the above agenda items pursuant to A.R.S § 38-431.03(A)(3). Members of the Board may attend in person or by telephone conference call. Public comment will be taken. Members of the public may address the board during the Call to the Public section of the agenda. Public members will be allotted three minutes each for this purpose.
