The agenda may be revised prior to the meeting as authorized by A.R. S. § 38.431.02. In that event, an addendum to the agenda will be noticed and posted prior to the meeting. Agenda items not noticed for a specific time may be taken out of order. The Board may go into Executive Session for the purpose of obtaining legal advice from the Attorney General's Office on any of the above agenda items pursuant to A.R.S § 38-431.03(A)(3). Members of the Board may attend in person or by telephone conference call. Public comment will be taken. Members of the public may address the board during the Call to the Public section of the agenda. Public members will be allotted three minutes each for this purpose.
