The Board will discuss and may vote to take action on the following matters:

1. Welcome and Introductions of the Arizona Game and Fish Commission Appointment Recommendation Board.

2. Review, Approval, and Signing of Minutes.

The Recommendation Board will telephonically review and approve the minutes from the November 3, 2011 and November 15, 2011 meetings.

3. Future Meeting Schedule and Locations.

The Recommendation Board is not scheduled to reconvene until October 2012, when they will be reviewing applicants for the Governor's 2013 Appointment for the Arizona Game and Fish Commission.

Agenda items not noticed for a specific time may be taken out of order. The Board may go into Executive Session for the purpose of obtaining legal advice from the Attorney General's Office on any of the above agenda items pursuant to A.R.S § 38-431.03(A)(3). Members of the Board may attend in person or by telephone conference call. Public comment will be taken. Members of the public may address the board during the Call to the Public section of the agenda. Public members will be allotted three minutes each for this purpose.
