- Congress has returned from its President's Day district work period and is beginning the budget process
- *Senate Committee on Environment and Public Works* met and heard testimony from the EPA Administrator, S. Johnson, regarding the Presidential budget request for FY09
- The Department of the Interior plans to have a new proposal submitted by April 30th (at the request and pressure received from more than 50 Senators) about regulations regarding carrying firearms into lands overseen by the National Parks Service and the Fish and Wildlife Service.
