**POSITION INFORMATION:**

The Arizona Game and Fish Department is seeking students to work during the summer to perform duties in the area of wildlife management. Students will perform duties under close supervision. Duties may include: collecting data, tracking, monitoring and counting animals, computer entry, developing educational materials, conducting creel surveys, fish sampling, habitat measurement, fish stocking. Some positions require hiking, camping, swimming or varied hours on some assignments. Assignments will begin on May 21, 2012.

**ELIGIBILITY REQUIREMENTS:**

The student must be currently enrolled in a curriculum leading to a Bachelor's or Post-Baccalaureate degree on a substantially full-time basis (usually 12 semester hours) and must be pursuing a major field of study closely related to wildlife biology or wildlife management. All positions require a valid driver's license with no applicable restrictions.
