Congress has reconvened after their two week traditional spring hiatus.

Most Americans have already heard of the precedential passage of a federal healthcare package, which will keep the US Department of Health and Human Services extremely busy over the next several months. Even with a statutory deadline for wrapping-up the FY-11 budget package, it appears to have taken a backseat to the aforementioned. This month Congress will likely finish up work on the budget and a financial services reform bill sometime in May. Congress is well on its way to missing the April 15th deadline for the FY-11 budget. During the week of April 12th, Congress is scheduled to vote on short-term extension of unemployment insurance benefits.

While legislation continues to be dropped by members, there is not a great deal of movement on other policy legislation, particularly natural resource-related measures, outside of some of these larger regulatory reform measures.

Congresswoman Ann Kirkpatrick (CD-1) recently dropped an identical companion measure to S.409, the Southeast Arizona Land Exchange bill. The bill could now bypass the House Committee on Natural Resources, chaired by Congressman Raul Grijalva (CD-7), which has been a concern for proponents of the bill.
