- Today, May 4th marks the **124th** day of the First Regular Session of the 48th Legislature.
- **Budget** negotiations are ongoing; the Governor has agreed to sign the Senate version of the budget however the House has not agreed to this version. Session has been extended to May 18th.
- **HB 2443** *off-highway vehicles; user fee* has not been placed on an agenda in the Senate as of today. *Information will be forthcoming.*

H2116 (Chapter 5): GAME & FISH; BIG GAME PERMITS; GRANDCHILDREN	The list of persons who may transfer a big game permit is expanded to include grandparents who may transfer a permit to a minor grandchild. The minor must be accompanied in the field by the transferring grandparent or the minor's parent or guardian. AS SIGNED BY GOVERNOR.	First sponsor: Rep. Jerry Weiers	4/6 signed by governor. Chap. 5, Laws 2007.
H2117 (Chapter 66): GAME & FISH; BIG GAME PERMITS; TRANSFERS	The list of people to whom a holder of a big game permit may transfer the permit is expanded to include a minor child with a permanent physical disability (defined). If the child is younger than 14, the child must complete the hunter education course offered by Dept of Game and Fish.	First sponsor: Rep. Jerry Weiers	4/16 signed by governor. Chap. 66, Laws 2007.
H2443: OFF- HIGHWAY VEHICLES; USER FEE	Effective July 1, 2008, various changes in statutes related to operation of off-highway vehicles, including a requirement that off-highway vehicles display a sticker (or indicia) issued by the Department of Transportation and that a fee is charged for the indicia. Proceeds from the sale of indicia will be used by the State Land Department to mitigate the impact of vehicles on its land. Off-highway vehicles must have certain equipment and minors operating an off-highway vehicle must wear helmets. Violations are considered civil traffic violations. 	<p>established for off-highway vehicles, which must systematically replace the current plates, and which are no longer valid for the life of the vehicle. Off-highway vehicles are subject to a vehicle license tax of \$3 instead of the regular VLT rate. It is a class 3 misdemeanor to drive an off-highway vehicle off of an existing road or trail in a way that causes damage to wildlife habitat, cultural or natural resources, or property; to drive an off-highway vehicle on closed roads or trails; to operate an off-highway vehicle in connection with acts of vandalism or other crimes; or for anyone other than a government agent to place or remove a regulatory sign governing off-highway vehicle use on any public or state land. H2137: GAME & FISH LICENSES; DISABLED VETERANS	The Game and Fish Commission may issue complimentary licenses to veterans who have disabilities rated as less than 100% disabling, but who are rated as individually unemployable (previously, only veterans with disabilities that are 100% disabling were eligible). To qualify for complimentary licenses, disabled veterans must provide a letter from the U.S. Department of Veterans Affairs stating their disability rating.	First sponsor: Rep. Rios	1/22 withdrawn from House <u>trans</u> and additionally referred to <u>nat res-pub.</u>
H2227: RESTAURANTS; ILLEGAL FEEDING OF WILDLIFE	Patrons of a licensed restaurant are added to the list of situations that do not constitute illegal feeding of wildlife. Retroactive to September 21, 2006. DEAD	First sponsor: Rep. McClure	1/18 referred to House <u>jud.</u>
H2781: BUDGET; GENERAL APPROPRIATIONS	The 'feed bill' providing funding for state agencies. Those agencies on biennial budgets are funded for two years; those with one year budgets are funded for fiscal year 07-08. Some representative agencies: AHCCCS gets \$5.6 billion (\$250 million more than in FY07); the attorney general gets \$46.5 million in FY08 and \$46 million in fiscal 09; basic state aid (a line item within the budget of the state board of education) increases to \$3.8 billion in FY08 from \$3.0 billion in FY07. Includes 96% of the Commission approved Budget.	First sponsor: Rep. Boone	5/1 from House <u>appro</u> with <u>amend #4369.</u>

H2783: BUDGET; CAPITAL OUTLAY; APPROPRIATIONS	Funding for capital projects in fiscal 2007-08, including \$245.5 million for state highway construction, \$25 million for airport planning and development; \$16.8 million to the Board of Regents for university construction; and \$6 million for planning and design for Capitol Mall renovation and construction. Capital Budget for Dept. includes all projects requested.	First sponsor: Rep. McComish	5/1 from House <u>appro do</u> pass.
H2788: BUDGET RECONCILIATION; ENVIRONMENT	Various statutory and non-statutory provisions related to the environment in the fiscal 07-08 budget, including: the amount in the livestock and crop conservation fund in the Dept of Agriculture that may be used for administration of programs is increased to 10% of the \$2 million annually appropriated from 5%; and \$6.3 million in the assurance account of the underground storage tank revolving fund may be used for administration of the leak prevention program and for the used oil program. S1026: EXTREME DUI; SENTENCE	Language giving a judge the discretion to suspend all but 10 days of a jail sentence for extreme DUI if the defendant completes a court-ordered alcohol or drug treatment program is deleted.	First sponsor: Sen. Waring	1/25 Senate COW approved with floor amend <u>#3064</u> ; amend 3018 was withdrawn.
S1029: DUI; EXTREME; 0.20 CONCENTRATION ENHANCEMENT	A person convicted of DUI (BAC of 0.08) shall be ordered to equip any vehicle the person operates with an ignition interlock device for a minimum of 12 months. If a person who is convicted of extreme DUI has a BAC of 0.20 or more (exceeding the extreme DUI threshold of 0.15), sentencing minimums are increased, for example for a first violation the person must serve a minimum of 45 days in jail and pay a \$500 fine	First sponsor: Sen. Waring	4/24 Senate refused to concur in House amendments and named Waring, Cheuvront and L Gray to a <u>FREE Conference</u>

	(increased from 30 days and \$250); for a second violation within 84 months, the minimums are 180 days in jail and a \$1000 fine (increased from 120 days and \$500). Additionally, for those convicted of extreme DUI with a BAC of less than 0.20, an ignition interlock device is required for 18 months; if the BAC is 0.20 or greater, the device is required for 24 months. S1086: TECH CORRECTION; FEDERAL FUNDS	Minor change in Title 35 (public finances) related to federal funds. Apparent striker bus. Includes 96% of the Commission approved Budget.	First sponsor: Sen. Burns	5/9 from Senate <u>appro</u> with amend #4396.
S1088: TECH CORRECTION; ELDERLY; RESPITE CARE	Minor change in Title 46 (welfare) related to respite care for the elderly. Apparent striker bus. Capital Budget for Dept. includes all projects requested.	First sponsor: Sen. Burns	5/9 from Senate <u>appro</u> with amend #4393.
S1252: EXTREME DUI; SENTENCING	The option for a judge to suspend all but 10 days of the otherwise mandated 30-day jail sentence for first offenders of extreme DUI (BAC of 0.15 or more) if the person completes a court ordered alcohol or other drug treatment program is eliminated. Likewise in the event person had been convicted of a prior extreme DUI within the previous 84 months, the option for a judge to suspend all but 60 days of the otherwise mandatory 120-day jail sentence is eliminated. Additionally, in each case the court may order the defendant to not consume alcohol for a period of time (minimum of 30 days for a first offense; 90 days for a second offense within 84 months) and be monitored daily for alcohol consumption.
