

EXHIBITOR / VENDOR PACKAGES

MAIN TENT

Standard Package- \$300 (or \$250 before January 1, 2008*)

- 10'x10' booth with skirted table, exhibitor sign, chairs, electrical source, side dividers (10' rear drape / 3' side drape).

Premium Location Package- \$500 (or \$350 before January 1, 2008*)

- 10'x10' booth with skirted table, exhibitor sign, chairs, electrical source, side dividers (10' rear drape / 3' side drape).

**There is a limit on premium location space; they are reserved on a first-come, first-serve basis.*

Center Island Package- \$750 (or \$600 before January 1, 2008*)

- 20'x 20' booth with skirted table, exhibitor sign, chairs, electrical source, side dividers (10' rear drape / 3' side drape).

**There is a limit on center island locations; they will be reserved on a first-come first-serve basis.*

NON-PROFIT

(OHV, Conservation Organizations, Fishing Organization or other non-profit), AGFD internal, Arizona State Agencies or BASF User Groups:

Standard Non-Profit Package- FREE

- 10'X10' booth outside of main tent, in Family Adventure area, on one of the appropriate shooting ranges, or other locations as determined by availability.
- Non-profit organizations may need to provide their own set up (table, chairs, shade cover and other items needed for presentation).

FIRING-LINE PACKAGES

Rifle, Handgun, Shotgun, Archery

'Firing-Line' Package A (firearm, archery and/or shotgun manufacturers)-\$1,500 (or \$1,250 before January 1, 2008*)

- 10'x30' booth on appropriate shooting range for merchandise and customer shooting, exhibitor sign, 8' tables, chairs, shooting frames, and canopy. This booth will be in a premium location.
- If you are a vendor that provides shotguns to customers, you may have a complementary shotgun booth at the Clay Target Center as well as a handgun, rifle and/or muzzleloading booth in the main area.

'Firing-Line' Package B (firearm, archery and/or shotgun manufacturers)-\$1,000 (or \$750 before January 1, 2008*)

- 10'x20' booth on appropriate shooting range for merchandise and customer shooting, exhibitor sign, 8' tables, chairs, shooting frames, and canopy.
- If you are a vendor that provides shotguns to customers, you may have a complementary shotgun booth at the Clay Target Center as well as a handgun, rifle and/or muzzleloading booth in the main area.
