Project Type: Water Drinkers

Brief Project Summary: Water availability in Northern GMU 5A has historically been unreliable due to lack of rain, lack of dirt tank reliability, and livestock pipeline/drinker reliability/availability. This project looks to replace several degraded metal water trough float systems with new round tractor tire design drinkers off of the existing pipeline for the benefit of wildlife and livestock. While these waters were originally built for livestock use and will continue to benefit livestock, it should be noted this project focuses on increasing water reliability and availability for wildlife when livestock are not present.

NEED STATEMENT – PROBLEM ANALYSIS: Water availability in Northern GMU 5A & 5BN has historically been unreliable. Lack of rain, effectiveness of dirt tanks due to soil type, and livestock pipeline/drinker reliability/availability has all contributed to the unreliability of available water for wildlife. When water is available, it is usually through the current livestock watering system. The existing livestock pipeline and drinker system is more than 50 years old and is becoming unreliable at best. The Bar T Bar ranch is currently in the process of replacing existing pipelines, but would like some assistance in replacing drinkers that benefit both livestock and wildlife. It should be noted that out of all the drinkers being proposed, only one is solely livestock use, which the proposal includes adding a wildlife drinker off of that existing drinker.

PROJECT OBJECTIVES: Increase water availability and reliability for wildlife in northern GMU 5A & 5BN. This project would essentially allow year round water availability for wildlife, which is currently not available.

PROJECT DESCRIPTION AND STRATEGIES: This project looks to replace several degraded metal water trough float systems with more reliable round tractor tire design drinkers off of the existing pipeline for the benefit of wildlife and livestock. While these waters were originally built for livestock use and will continue to benefit livestock, it should be noted this project focuses on increasing water reliability and availability for wildlife when livestock are not present through design changes to minimize freezing complications with stored water in metal drinkers and floats.

- Dog Valley- replace existing drinker w/ 12' rubber tire design (RTD)
- Norfolk Well – replace existing drinker in water lot w/ 12' RTD and add 8' RTD outside water lot for wildlife use
- Canyon Diablo- replace old float box w/ 8' RTD
- Quayle Well- replace existing drinker w/ 12' RTD
- Summerfield- replace existing drinker w/ 12' RTD
- “Pink Floyd”- replace existing drinker w/ 10' RTD

PROJECT LOCATION: The project area is spread throughout several different areas. However, the general area could be summarized by boundaries such as Red Hill on the SE corner, the forest boundary on the NE corner, West Sunset on the NW corner, and Anderson Rim on the SW corner.

The Bar T Bar is requesting \$5348.99 cash assistance to purchase materials and installation costs for the proposed drinkers.

Cost Share or Matching Funds

The Bar T Bar will be administering and conducting project oversight at an estimated 12 hours @ \$25/hr which equals \$300. The Bar T Bar will also be providing an 8' tire as a drinker and installing it at the rate quoted above which would equal \$1200. The Bar T Bar then would be providing an additional \$3848.99 cash or labor match equaling \$5348.99. This would complete the project at a 1:1 cost sharing ratio.
